1. Pursuant to the resolution of the 204th Annual Conclave of the Grand Commandery of New York in Albany, New York. The 205th Conclave will convene at Albany, New York on September 14th, 2018 at 1:45pm and conclude Sunday Morning September 16th 2018 at the completion of the Passing of the Cords Ceremony.

The headquarters will be the Red Lion Hotel (formerly Radisson Hotel), 205 Wolf Road, Albany NY 12205. All meetings and activities will be held at this location.
